## *Message from CWCA President Brian Shane*

Greetings to all our Caine Woods homeowners and residents. I'm Brian Shane and I'm your new association president. It's my pleasure to make your acquaintance.

It goes without saying how challenging this year has been for all of us. Some of us may even have lost loved ones as a result of this global health crisis, or know people who have. My thoughts are with those of you as we patiently wait for the pandemic to end.

It's my belief that this crisis only has strengthened our sense of community, knowing that we're all in this together.

On the bright side, this year, we took the idea of social distancing and made it work for us: Instead of holding a crab feast for hundreds of people at once in the same location, which proved impossible because of the pandemic, we

turned our annual crab feast tickets into de facto gift cards. Doing it this way was a hit! In the future, we may consider offering a hybrid of this year's ticketed system and our traditional in-person feast.

I'm also pleased to report that our crab feast tickets have raised thousands of dollars for local charities, including a scholarship fund for men and women pursuing a law enforcement career here in Ocean City. The OCPD scholarship fund was established in memory of two beloved police officers, Tommy Geoghegan and Josh Adickes, who were lost to us in a tragic 2013 plane crash. We're excited to help get this new charity off the ground and to continue supporting our local police department.

Speaking of police, we're also glad to be collaborating with the OCPD and other municipal agencies in pursuit of safer

Caine Woods roads. Many of you already know that I met with the Ocean City Council at their most recent meeting, and the council is in support of finding solutions to the problem of unsafe driving throughout our community.

City Engineer Terry McGean followed up by coming to our Oct. 28 association meeting at Fiesta Park. Terry listened to our concerns and shared some ideas on traffic management that may be implemented in the not-too-distant future.

My wife and I are proud to call Caine Woods home, and I'm excited to be in this role for the next three years. It is my privilege to serve not only as your association president, but as your neighbor and your friend. If you rent your property to anyone at any time, the law requires you to obtain an Ocean City rental license and an OC noise control permit. This applies to online rentals as well. Compliance with the laws, ordinances and regulations within the city and state ensures safe, healthy and habitable housing conditions in rental housing units.

Applications may be obtained at City Hall or by calling 410-289-8833.

Properties that may be in violation of rental license or a safety, building or health code should be reported to City Hall at 410-289-8855.

## Cyberthieves are posing as major companies in phishing schemes

Have you received an unexpected email, phone call or text from a major company like Amazon, Google or Apple? Before you respond to an email, text or call, know that it's probably a scam, according to the Maryland Consumer Protection Division.

Often, these emails/calls/texts will state that your account has unusual or suspicious activity; your account needs attention; you need to update your payment information; or you need to take some other action, usually "urgently."

Other times, you may receive what looks like an order confirmation, which may or may not include an attachment, for an item you didn't purchase.

A scam email or text will often ask you to click a link, open an attachment or call a number to resolve the issue. When people respond, they're often asked to purchase gift cards or visit a website to input payment information to resolve the issue.

You should never call any number, open any attachments or visit any website one of these calls or emails tells you to. The link could send you to a malicious website or launch a virus into your computer or phone.

Major companies like Amazon, Apple and Google will not ask you for personal information unless you initiated the call. If your phone service allows it, you may wish to block the suspicious caller's number.

There are red flags that can tip you off that you're dealing with a scam. It could contain poor grammar and/or spelling, or the content just seems strange or far-fetched. If the email originated from a different account than the supposed company trying to contact you, it may be fraudulent. If the link says [www.amazon.com](http://www.amazon.com), but displays something completely different when you hover your cursor over it, it may be fraudulent. Finally, if you didn't sign up for text messages or alerts from a particular company, you should ask yourself why they would contact you that way.

If you do need to contact a company's customer support, go directly to the company's official website.

If you provide information or purchase gift cards at the request of these scammers, recovering your money will be very difficult. Providing personal information also makes you vulnerable to identity theft. If you believe you have been a victim, contact your local police department.

## Takes steps to secure your home

We urge everyone to make sure that your houses are safe and secure. Please lock all doors and windows and we recommend that you have outside lighting, especially in the back yard. Motion-detector lights are particularly effective and efficient.

Please report **any** suspicious activity or persons to the police, using 911 or the non-emergency number, 410-723-6610.

If you plan on being away from home for a while, you can subscribe to the Ocean City Police Department's residential security check program. Call the OCPD at 410-723-6610 or go to [www.oceancitymd.gov](http://www.oceancitymd.gov) for more information.

## OC Police establish surveillance camera registry

The OC Police Department is using surveillance footage as an investigative tool more often as residential and commercial surveillance cameras rise in popularity. To find available cameras more easily, the OCPD has established a registry.

Surveillance camera footage has been a part of countless investigations in recent years. Currently, when an investigator feels that surveillance footage would be helpful to a case, the officer must determine where cameras are located and if they would be helpful. The registry allows officers to locate cameras quickly, and to have a detailed description of the camera along with the property owner's contact information.

## What to do if you smell gas

Natural gas and propane are safe, reliable and convenient, and it adds to our comfort, so why does it have to smell so bad?

Natural gas and propane are odorless by nature, so for safety's sake, an odorant called mercaptan is added so that you will know if gas is escaping and recognize that a potentially dangerous situation may exist.

Natural gas and propane that have escaped can enter locations (including properties that don't have natural gas service) by migrating and entering through openings. So, if you ever detect a "rotten egg" smell in or near your home or place of business, take the following precautions to help keep your family, friends and colleagues safe.

Remember, if you smell gas:

- Do leave your home or building immediately.
- Do immediately call your local emergency number (911) from a cell phone outside the home or building, or from a neighboring location, to immediately report the suspected gas leak.
- Do not use your telephone, turn on or off the light switches, light a match or do anything that might create a spark or flame.
- Do not re-enter the building where the leak is suspected until emergency professionals give the OK.

# Caine Woods history: 2002-2003

In 2002/2003 our officers were Glenn Steckman, president; Lloyd Martin, vice-president; Tonja Sas, treasurer; Robert LeMay, secretary; Margaret Sas, corresponding secretary; Joe Coleman, auditor.

Board members were Henry Ammerman, Jim Aschenbach, Frank Buscemi, Irene Hansen, Fran Kennedy, Jack Nickels, Mark Paddack, Agnes Schaper and Jeanette Tressler.

City Council member Vince Gisriel and Steckman led a discussion on the proposed north end bus depot across from the property on 144th Street owned by the Catholic Diocese of Wilmington. Board members asked that city officials attend an upcoming meeting.

The CWCA was raising funds to place a Christmas tree on the median strip on



Coastal Highway. To date \$746 had been collected of the \$1,500 needed.

Lighthouse Village condos had burglaries, assaults and malicious destruction of property. The OC Police Department increased bike patrols in the neighborhood.

The City Council voted to provide a parcel of land for a new library in Ocean City.

The notorious peeper from Delaware was sentenced to one year and three years probation.

There were problems at Fenwick Inn.

The CWCA wanted a meeting place in our neighborhood. The Tiburon condominium did not allow us to meet in their meeting room. So meetings were held at St. Matthew's by the Sea in Fenwick Island. The board voted to contribute \$100 to St. Matthew's.

Fran Kennedy planted flowers and plants in the five flower beds around Caine Woods and they were very attractive. She continued to keep them clean, including picking up beer bottles in some places.
